

ANALYSIS PROCEDURE OF FEEDBACKS FROM DIFFERENT STAKEHOLDERS

The University has adopted the UGC Regulations, 2018. The Clause 6.VII of the Regulations provides that –*“The Internal Quality Assurance Cell (IQAC) shall be established in all Universities/Colleges as per the UGC/National Assessment Accreditation Council (NAAC) guidelines The IQAC may also introduce, wherever feasible, the student feedback system as per the NAAC guidelines on institutional parameters without incorporating the component of the students’ assessment of individual teachers in the Assessment Criteria and Methodology Proforma.”*

Accordingly, University’s IQAC has devised format for the feedback to be taken from different stake holders, like students, parents, alumni and teachers of the University and placed to the 15th meeting of the Academic Council held on 27th November, 2018. 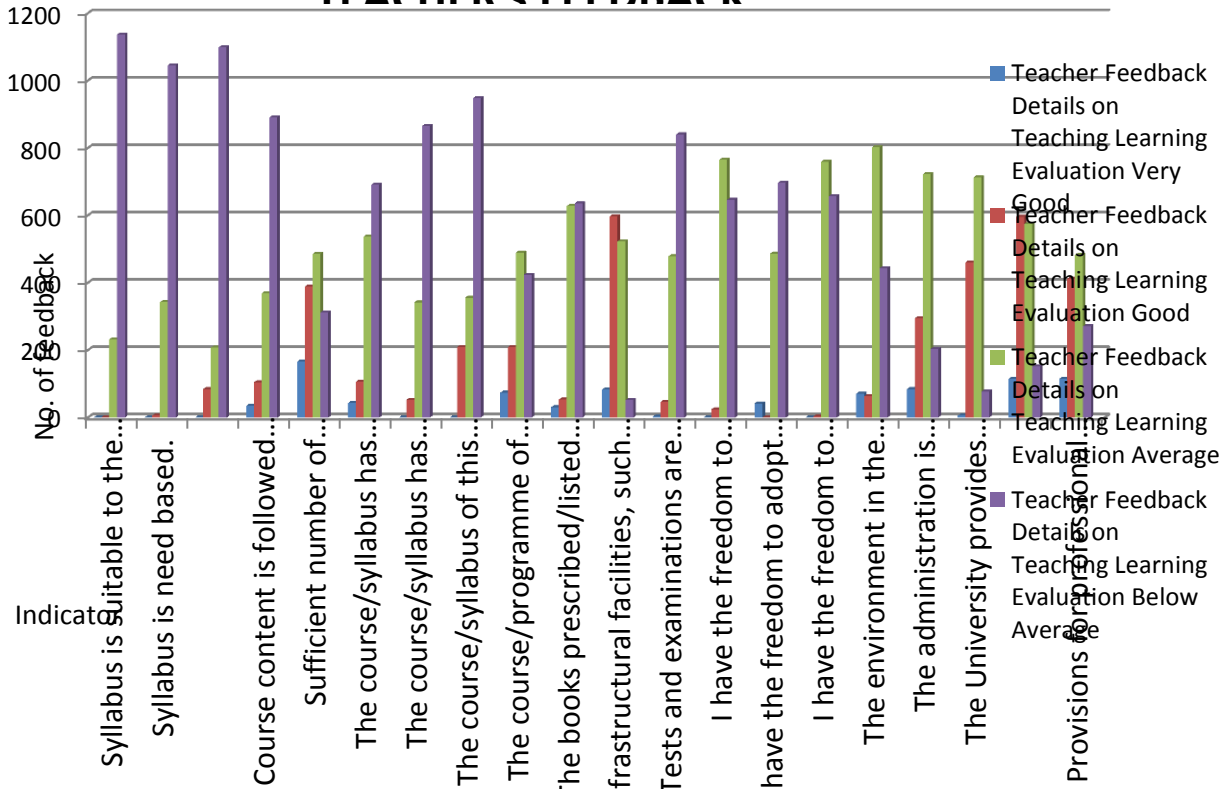

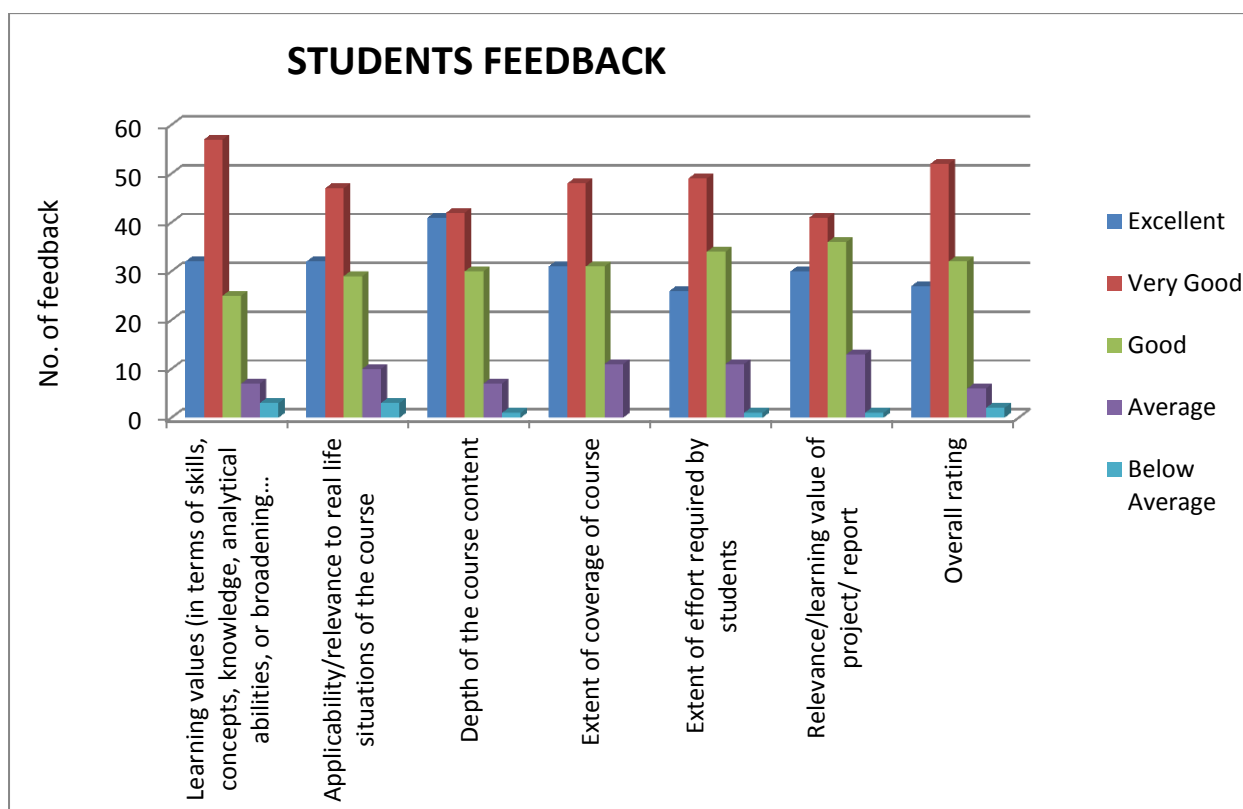

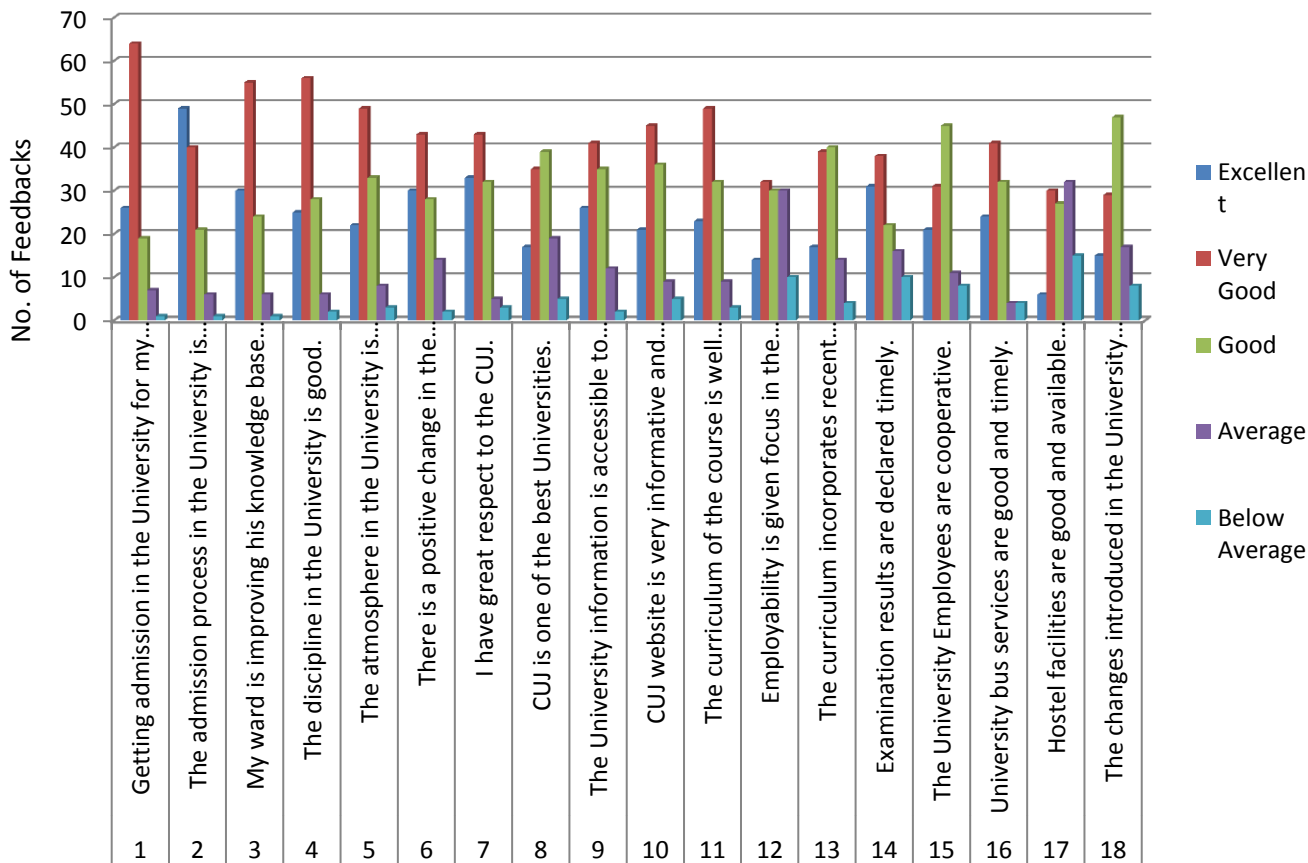
