Approval of MA Syllabus, of MA in Human Rights and Duties (as per UGC Syllabus on Human Rights and Duties)

Resolutions of Board of Studies:

The Board recommend following:

1. MA Courses in first and second Semester to be designated as Core Courses.
2. In third and fourth Semester there will be five Courses, in which Course 15 and Course 16 will be Compulsory Core Courses and the two Courses proposed in Resolution No. 8 will be offered in third and fourth Semester respectively. Any other Course to be proposed in future as an 'Optional Course' will be added in the third and fourth Semester.
3. Experts suggested the Centre to offer more Optional Courses for MA Course Work in future.
4. Course 15 will be exchanged with Course 9
5. Course 15 and Course 16 (in the proposed Syllabus) will be Compulsory Core Courses
6. Course 13 and Course 14 will be renamed as:
  - (i) Course 13: Human Rights and Environment
  - (ii) Course 14: Human Rights and Media
7. In Course 8 'Revolutionary Movements' has to be added as one of the topics.
8. In every Course there has to be 'Objective of the Course' to be included.

The Board has approved MA Syllabus after consideration and above recommendations.

The research proposals of Mr Abhinit Tirkey and Mr Rameshwar Nath have already been approved in their respective doctoral committees and now submitted for the approval. Research Proposal of Ms Pratima Sharma is put forward for consideration of the Board, as DRC suggested for various modifications.

Board of Studies consideration again. All other matter shall be regulated by the Dean, School of Humanities and Social Sciences.

4. The PhD title of Mr Rameshwar Nath, 'Human Rights of Under-trial Prisoners: A Case Study of Central Prisons in Jharkhand' has been considered and passed by the Board of Studies.

Ms. Pratima Sharma might continue with Dr. Saurabh or any other suitable faculty (outside CUJ) who expertise in her area of study as a Co-Supervisor, if University Regulations allows so. And, if Ms. Pratima is continuing under Dr Rajashree Padhi or under any other guide of the Centre, then she has to write a new Synopsis in accordance to the specialization of her Guide.
