Concept Note

Tribal Culture and Philosophy in Oral narrative

Every community has life, literature, culture and philosophy, which is the means for its sustenance, wellbeing and success. It is well known that tribal communities have unique cultural traits and philosophical view of their world. Due to certain factors, most of the tribal communities' philosophical view of their life is unknown/ lesser known to the other communities/ mainstream communities. Oral narratives act as both ontology and epistemology in Indigenous knowledge system. On the one hand, it is very pertinent to understand, document and preserve the tribal philosophical thoughts of its community and cognitive system. On the other hand, oral narratives are the store house which needs to be analysed and interpreted in order to know the Tribes, Nature and their way of Life.

Philosophical approach will be applied from cultural and folkloristic point of view.

The tribal communities are having many legends, and the legendary characters and their extraordinary doings and other events are believed by them as true. The tribal communities are known for possessing a treasure of proverbial expressions, though they do not belong to the oral narrative category, their interrelationship with oral narratives cannot be denied. For example, many of the tribal proverbs are the abstractions of tales and the tribal people are having many tales to either justify or explain the proverbial expressions. Similarly, another form of oral tradition that employs tales and other oral narratives is known as folk speech, for instance, one can use a tale or personal! narrative to tease a person or joke at him or use at least while coining a nickname. Further, the tribal communities are also having other forms of folklore that are having their close association with the oral narratives and they include tribal paintings, tattooing, various performing arts, tribal worships and rituals. Thus, the oral narratives are inseparable from the social and cultural life of the tribal and non-tribal communities. However, there is a need for studying the condition or oral narratives in the context of globalisation process, a universal process that has created many positive and negative impacts on the indigenous communities, in particular. The globalisation has resulted in the increased mobility of persons, goods, capital, data and idea, etc.
