- 1. The Shortlisting Committee checked and verified the records of each applicant and determined their eligibility strictly in accordance with the minimum qualification prescribed by the University vide Advt. No. CUJ CUJ/Advt./01/2018-19 dated 08.03.2019; UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education 2018 (herein after referred to as UGC Regulations).
- 2. Applicants not meeting the minimum eligibility requirements as per the UGC Regulations 2018 were declared Not Eligible and reasons for declaring an applicant as ineligible are clearly indicated against their names.
