It was also noted that the Under Secretary, Govt. of India, MHRD, vide his letter no. F.42-26/2009-Desk (U) dated 12<sup>th</sup> April 2010 (Annexure II) has informed that the President in her capacity as a Visitor of the Central University of Jharkhand, in exercise of powers vested in her under section 27(3) of the Central Universities Act, 2009, has been pleased to amend Statute 11 of the said University to add the following proviso there under:

"Provided that for a meeting of the Executive Council constituted under the transitional provision of section 44 of the Act, five members shall form a quorum"

The Chairman reported that J. N. U. was contacted and due modification in the Format for Annual Budget and Annual Account were made in accordance with the J. N. U. pattern/format. A straight line depreciation method was also done. The same was placed before Dr. B. P. Mathur.

Dr B. P. Mathur observed that the revised balance sheet of the CUJ was prepared in accordance with discussion held in the Finance Committee Meeting and noted that depreciation schedule has been prepared on straight line depreciation of fixed assets. He then certified that revised balance sheet stood corrected and be approved.

The Executive Council resolved that the Budget Plan for 2010-11 and Annual Account 2009-10 as per (annexure VIII, IX, X) be approved for further processing through A.G. The audited Annual Account would then be sent to the Govt. of India for laying before Parliament.
