The Chairman warmly welcomed the members present in the 11<sup>th</sup> meeting of the Executive Council. He expressed his deep gratitude for their coming from different parts of the country personally to advise the University in its endeavour to create a Centre of Excellence.

First of all, the Vice Chancellor on behalf of the members as well congratulated Prof. R.N.K. Bamezai for being awarded the prestigious "Padmashree" for his significant contribution in the field of Science & Engineering and wished him many more achievements.

The Chairman gave a brief introduction on the Agenda items, highlighting the Annual Report and Annual Accounts as the main Agenda.

The Vice Chancellor also highlighted some of the recent academic achievements. These included the month long attachment with the Centre of Life Sciences of a Scientist, Dr. Hamdino M.I. Ahmad, from Egypt, under the DST sponsored CV Raman International Fellowship for African Researchers and another similar Researcher opted this University for his research work; the sanction of two UGC major Research Projects in English have been received - one to Professor B.P. Sinha, titled "Multicultural Response to Lost Tradition with Special Reference to Tribal Literature in Jharkhand" and another to Dr. Sandeep Kumar Yadav titled "Abrogating 'Authenticity' with a Difference: Indian Poetry in English since 1980-2000"; CUJ has been included as Associate Partner of "Erasmus Mundus Action 2" where 8 (eight) European Union Universities and 10 (ten) Universities from India are establishing a consortium (Ghent University of Belgium is coordinating); with the exit option in CUJ after the 3rd year, two of our students have been admitted into prestigious institutions for their post graduate studies - Mr. Raman Gupta of the Centre of Applied Mathematics has successfully been admitted to the Integrated Ph.D. Programme of TIFR Center for Applied Mathematics, Bangalore and Mr. Jami Amaresh of the Centre of Business Administration has been admitted to Dublin City University, Ireland for a PGDM Programme; Dr. Rabindra Nath Sarma of Centre of Indigenous Culture has been invited as an Visiting Faculty for two months by the Department of Estonia and Comparative Folklore University of Tartu, Estonia

The University has also progressed successfully in its endeavour to network and establish collaborative programmes with foreign Universities which include proposals received for MoUs with St. Theresa International College, Nakornnayok, Thailand, Mahasarakham University, Thailand, California State University, San Bernardino, USA and China-South Asia Business Forum. All students of Mass Communication and Business Administration have found good placement for Internship in different parts of the country and with well known organizations & companies.

Dr. Biplab Kumar Kuila, Assistant Professor, Centre for Applied Chemistry has been awarded with Ramanujam Fellowship along with the financial assistance from DST, New Delhi (Annexure VI). In the terms & conditions of the fellowship it is mentioned that the incumbent has to opt for either this fellowship or his present position/Fellowship, if any.

Dr. Kuila has requested for availing the fellowship and also to allow him to continue as Assistant Professor. Further he has requested that he will opt for the fellowship amount @ 75,000/-per month and will not claim his present pay/salary for the post of Assistant Professor during the tenure of 05 years.

A clarification has been sought from UGC whether the person awarded with Ramanujam Fellowship for a period of five years is permissible to avail the fellowship as well as he can continue to work on his present position i.e. Assistant Professor. Also whether the above period of five years availing the fellowship can be treated as on duty (Annexure VII). The reply is awaited.

As per clause 7 of OC-2 of the first Ordinance of the University is as follows: (Annexure XVI)

"a. it shall be the duty of the Registrar to place before the Executive Council the case confirmation of a teacher.

b. The Executive Council may then either confirm the teacher or decide not to confirm him/her. Where the Executive Council decides not to confirm the teacher, she/he shall be informed in writing to that effect.

Provided that the decision not to confirm a teacher shall require a two thirds majority of the members of the Executive Council present and voting,"

As per the UGC Regulation 2010 (Annexure XVII)

- Probation and confirmation rules are applicable only at the initial stage of recruitment, issued from time to time, by Central Government.
- All other Central Government rules on probation and confirmation shall be applicable mutatis mutandis.

As per the Govt. of India Rules the case of confirmation will be placed before the DPC after satisfactorily complete the probation. (Annexure XVIII)

The matter was placed before the Executive Council for consideration & advise.

#### Resolution:

The Executive Council discussed thoroughly about Para 11 of UGC Regulations 2010 on probation and confirmation and was of the view that this does not specifically mean for Teachers.

EC: 2012/11/013: To consider to interview a single shortlisted candidate belonging to SC category against the post reserved for SC category.

The University has advertised the posts of Assistant Professor, Associate Professor and Professor by observing roster as per Govt. of India Rules. Initially, the post of Professor was not reserved, however, reservation for the post of Assistant Professor & Associate Professor were provided for SC/ST category candidates. Whereas, in the recent advertisement, the reservation for Assistant Professor, Associate Professor and Professors have been provided to SC & ST category as well. The reservation for OBC has been provided at the Assistant Professor Level only as per the direction of UGC (Annexure – XIX). Only one post of PC category has been given so far to the Centre for Mass Communication as per Roster Point.

In the recent advertisement, at the time of shortlisting, only one candidate in SC category has been shortlisted to be called for interview. Now, the matter is that as to whether a single shortlisted candidate belonging to SC category be called for interview for the post reserved for SC category. The same policy may be decided and adopted for all other reserved categories also viz. ST, OBC & PC.

The matter was placed before the Executive Council for consideration and advise.

#### Resolution:

The Executive Council resolved to allow even single shortlisted candidate to be called for interview under the reserved category of SC/ST/OBC/PC applied for.

EC:2012/11/14: To consider and approve a Policy on disbursement of the amount received from MHRD for Evaluation/Feasibility study of NGOs be assigned as 70% and 30% to the University and Committee members respectively after making a Regulation on the matter.

An Evaluation/Feasibility study of NGOs for setting up new State Resource Centre (SRC) in Jharkhand has been carried out by the University as per the direction of Department of School Education and Literacy, MHRD, New Delhi. Accordingly, an amount of Rs. 53,094/- has been received from MHRD for payment of TA/DA to the Agencies who conducted feasibility studies of NGOs i.e. Central University of Jharkhand. At the time of disbursing the above amount, the Vice Chancellor desired to have a policy for disbursement of the same.

Accordingly, a Committee was constituted under the Chairmanship of Dean (Academic) and the Committee submitted its report (Annexure-XX) wherein, it has been provided that a Policy be adopted for disbursement of the amount received from MHRD for Evaluation/Feasibility study of NGOs be assigned as 70% and 30% to the University and Committee members respectively. It was also provided therein that in current situation 50% of the honorarium amount may be given to the University and 50% be paid to the Committee members for conducting this study in addition to other expenses on TA/DA etc.

The matter was placed before the Executive Council for consideration and advise.

#### Resolution:

The Executive Council resolved to approve that the amount be disbursed, after deducting the expenditure on TA/DA, etc., in the following ratio:

- A. 70% to the members of the Committee including supporting staff, if any.
- B. 30% to the University, out of which 15% for department to which the faculty belongs.
