Gender Based Violence is a phenomenon deeply rooted in gender inequality and is a significant example of human rights violation. Violence against women in public and private spheres continues unhindered because of lack of justice, lack of essential resources, lack of awareness about rights and laws that safeguard these rights. Most often the sufferers are dependent on their abusers.

Gender based violence includes or is likely to include acts that result in the physical, sexual or mental harm or suffering of an in individual. It could include verbal threats, use of force, deprivation of freedom and rights.
