 - a) **First Envelop** should be super scribed as "**TECHNICAL BID**" containing the **TECHNICAL SPECS** and firms credential; **TENDER COST**, in case the Tender Document is downloaded from the web site then the cost of the same must be enclosed; and **EMD**. The **TENDER COST & EMD** should be submitted vide Bank Draft only in favor of "Central University of Jharkhand" payable at S.B.I., Upper Bazaar Branch, Ranchi
 - b) **Second Envelop** should be scribed as "**PRICE BID**" containing the quoted rate.

Both the above envelops (a) & (b) should be enclosed in one big envelop super-scribing as

"TENDER DOCUMENT FOR SUPPLYING, FITTING AND FIXING OF FURNITURE AND FIXTURE (PART-A) AT CITY CENTRE, CENTRAL UNIVERSITY OF JHARKHAND, KANKE ROAD, RANCHI- 834008."

2. The Tender received without EMD and Tender Cost (in case the Tender downloaded from website) shall be summarily rejected.
3. If desired the tenderers or their authorized representatives only may be present on the day of opening of tender.
4. For clarification, if any, the same may be sought from the office of the undersigned at the above address.

5. The complete tender document is to be signed with seal & is to be placed in the technical bid envelope along with the necessary required catalogues/documents. The bidder shall submit satisfactory documentary proof. Authorized distributor/Principal certificate to be enclosed.
6. The tenderer should have supplied similar goods to other government organization and should produce documental evidence.
7. Central University of Jharkhand reserves the right to reject any or all prospective applicants without assigning any reason and to restrict the list of tendered contractors to any number deemed suitable by it, if too many applications are received satisfying the basic PQ criteria.
8. The decision of the Competent Authority of the University will be the final and binding to all. The Vice Chancellor, Central University of Jharkhand reserves the right to accept or reject any application and to annul the tender process and reject all applications at any time, without assigning any reason or incurring any liability to the applicants.
9. The University reserves the right to increase or decrease the scope of work or split the job. They are liable to change and must be considered only as advance information to assist the applicant.
10. If any information furnished by the applicant is found to be incorrect at a later stage, he shall be liable to be debarred from tendering/taking up of work in Central University of Jharkhand. The Central University of Jharkhand reserves the right to verify the particulars furnished by the applicant independently.
11. ***The rates must be quoted for service/materials, inclusive of all statutory taxes & levies; F.O.R City Centre, Central University of Jharkhand, situated at Kanke Road, Ranchi. No additional handling / liability charges will be entertained.***
12. Even though an applicant may satisfy the above requirements, University would be liable to disqualification if he has:
 - a) Made misleading or false representation or deliberately suppressed the information in the forms, statements and enclosures required in the pre-qualification document.
 - b) Record of poor performance such as abandoning work, not properly completing the contract, or financial failures/weakness etc.
