The matter was considered by the Academic Council. Members felt that more details need to be given with reference to books that were recommended. The number of experts under Indigenous Culture Study could also be increased.

Resolution:

- 1. The Academic Council resolved to approve the six new syllabii as presented.
- 2. The Academic Council recommended that during the 1st semester when faculties are recruited, the syllabus could be further reviewed for changes if any.

- 3. The Academic Council recommended that where courses are common in content, classes could be combined across different Centres.
- 4. The Academic Council recommended that in selected disciplines namely Nanotechnology and Water Engineering & Management the relevant Ordinances be amended to include the exit/entry provision after 4 years and that the degree awarded would a B. Tech degree after 4 years.

AC:2010/3/005 Guest Faculty for Academic Programmes starting July 2010

The Central University of Jharkhand will have 10 Academic Programmes starting from July 2010 of which 4 programmes will be 3rd semester level. Owing to time constraints in recruiting regular faculty, advertisements had been issued for Guest Faculty against the 10 Academic Programme. The qualifications are as per UGC Guidelines. The terms of engagement will be for six months on consolidated monthly remuneration of Rs. 35000.00 (Rs. Thirty Five thousand) only.

Applications have been received, the break up being:-

Selection Committee members would be comprising of subject experts at the national level. The recruitment is planned to be completed by the last week of June 2010, so as to engage the Guest Faculty in the first week of July 2010. Visiting faculty would also be invited as per need.

Matter was placed before the Council for information & consideration.

Resolution:

1. The Academic Council resolved to express its concern over time taken to receive the Visitor's nominee in order to have the Selection Committee meeting for the appointment of regular Faculty Members.



2. The Academic Council noted with satisfaction the response for recruitment as Guest Faculty. The Council recommended that Senior Rtd. Professors as well as active faculty could be appointment on contract or deputation.

AC:2010/3/006 Subject Panel of Expert for New Academic Programme.

The UGC has approved Six New Academic Programme for the year 2010-11. (Annexure III). Six faculty posts against each discipline have also been approved. These posts would be advertised across the country and overseas. Subject panel of experts would need to be drawn up against each discipline.

The Matter was placed before the Academic Council for Advice.

Resolution:

- 1. The Academic Council accepted and approved the panel of names circulated to the members
- 2. The Academic Council approved that each member would also send a list of suggested names within two weeks.
- 3. The Academic Council authorized the Vice Chancellor to include more names as per his discretion.

AC:2010/3/007: Central University Common Entrance Examination (CUCET)

The Admissions to the first session in the University was made on the basis of merit on plus two marks. For the session to 2010-11, it has been decided to hold a Central Universities Common Entrance Test (CUCET) 2010-11.

Seven new Central Universities have joined to have a common entrance examination. The Universities are Central Universities of Bihar, Karnataka, Kashmir, Kerala, Rajasthan & Tamil Nadu. There will be 29 examination centres.

The notification for the same has been made (Annexure V). It has been notified by the CUCET that the details like eligibility criteria, no. of seats available, reservation, fee structure, courses offered, admission process, format of the application form etc. will be provided by all the concerned Universities for the information of the candidates applying for the test and opting for the University.

The Central University of Tamil Nadu is coordinating. The Central University of Karnataka is receiving the examination application forms. The Central Hyderabad University has kindly agreed to assist with the evaluation.

The Matter was reported to the Academic Council.

Resolution:

The Academic Council welcomed the attempt in having a Common Entrance Examination Test among the Central Universities.



AC:2010/3/008 Central University of Jharkhand City Centre

The Central University of Jharkhand proposes to start a City Centre at Ranchi City. The Centre will have programmes that would cater to the public, particularly those who are working or studying.

Some of the programmes proposed to be conducted at the City Centre would include Merged Scheme programmes of UGC namely competitive examinations preparatory classes, Remedial Classes for ST /SC student and Language Teaching Classes. Other programmes would include short term Management Courses in :

- 1. Finance for Non Finance Managers
- 2. HR for Non HR Mangers
- 3. Performance Management Appraisal and Counseling.

The Management oriented classes are aimed at working people as well as non-management individuals. The course structures had been prepared in consultation with former faculty of XLRI, Jamshedpur (Dr. P. D. Thomas, Former Director, XLRI, Mr. Ronaldo D. Costa, Entrepreneur and Visiting Faculty of XLRI). A copy of the management course content is attached as **Annexure VI**. The time duration would range form 1(one) month to 5(five) months for the Certificate courses.

The Matter was placed before the Academic Council for Consideration.

Resolution:

- 1. The Academic Council approved the establishment of City Centre.
- 2. The Academic Council approved the proposed programmes to be started at the City Centre.
- 3. The Academic Council recommended that other programme also be started as per need & justification. These would be considered by the Council accordingly.



AC:2010/3/009 CUJ Brochure

Central University of Jharkhand (CUJ) has prepared a Brochure (Annexure VII), which contains details about the University, which was approved by the Vice-Chancellor of the University in his capacity as the Chairperson of Academic and Executive Councils. The major changes in brochure is on the new academic programme. The mess fee has also being increased from Rs.1800 per month to Rs. 2000 per month.

The Executive Council at its meeting on 15th May 2010 had ratified the orders of the Vice Chancellor approving the brochure and fee structure and advised the matter be also placed before the Academic Council for its record.

The Matter was reported to the Academic Council.

Resolution:

The Academic Council approved the draft of the new Brochure (2010).

AC:2010/3/011 MHRD note on P. M. O. request for celebration of Mother Teresa Chair

A letter No. 19-8/2010-Desk (U) dated 19th April 2010 from Director (CU), Department of Higher Education, MHRD, New Delhi (Annexure IX) has been received where in it is provided that as part of birth centenary celebration of Holy Mother Teresa from 26th August 2009, to 26th August 2010, Shri V. J. Hycinth, Chairman, Mother Teresa Global Foundation, a Socio Charitable Organisation involved mainly for the upliftment and empowerment of weaker and unorganized section of society especially women, children, orphans, handicapped etc, has sought the Prime Minister's intervention for establishing Mother Teresa Chair in all Central Universities in the country.

It is also stated in the letter that the Prime minister's Office has, in turn, requested the M.H.R.D. to take appropriate action, under intimation to P.M.O. office.

The director (CU), Department of Higher Education, MHRD, New Delhi, Gov. of India in his above letter has also requested the Vice-Chancellor of this University to apprise him of the University's considered view in the matter.

The matter was informed to the Executive Council at its meeting on 15th May 2010. The Executive Council expressed its favor and advised that the matter be placed before the Academic Council for its consideration

The matter was placed for consideration and advice.

The Academic Council Members welcomed the possibility of such chair being constituted in Central University of Jharkhand. The write up may need to be prepare statistics from State Government and the justification on having such a chair based in Jharkhand.

Resolution:

The Academic Council whole heartedly supports the establishment of a Mother Teresa Chair in the Central University of Jharkhand.

AC:2010/3/012 Reg. Raising of Research Capacities

A letter regarding Registration for raising of research capacities for increasing Ph.D. student numbers with a view to develop joint Ph.D. degrees has been received by the M.H.R.D viz. letter no. F:No. 33-1/2010-U.4 dated 1st April, 2010 enclosing herewith a copy of letter dated 27.1.2010 of Prof Keith Hoggart, Vice Principal (Arts & Science, External Relations) & Professor of Geography, King College, London addressed to His Excellency Kapil Sibal, Minister of Human Resource Development

The letter to the Minister has been written to follow up on the conversation they had at UKIERI reception on 30th January 2010, regarding a suggestion that one way to raise research capacity in order to support the ambitious plan of the Minister for increasing PhD student number is to develop joint PhD Degree. The details of the Model, mechanism, fee, agreement etc have been given in the letter.

The letter of Prof. K. Hoggart have two enclosures (a) for joint PhD degrees between the University of Hong-Kong and King's College London (b) Proposal for joint PhD degrees between the University of Hong-Kong and King's College London.

Indira Mehra, Section Officer, MHRD, Govt. of India has requested to furnish comment/Information in this regard vide a letter F. No. 33-1/2010-U4 dated 1st April 2010. **Annexure X.**

The matter was placed before the Academic Council for information and advice.

The Academic Council noted the matter and supports the interaction & collaboration of the Central University of Jharkhand with overseas Education & Research Institutions.
