**FC: 2018/16/01: Implementation of 7<sup>th</sup> Central Pay Commission.**

As per letter F.No.11-1/2017 (CU) dt.18.01.2017 of University Grants Commission, New Delhi "it may also be ensured that the institutions which are in a position to fully meet the additional financial impact or the institutions which are not in a position to meet either 30% or any lesser amount from their internal resources, the revised pay scales are allowed only after adjusting the amount so calculated. It is, therefore, mandatory that the internal resources are strictly and realistically kept in view for this purpose. The Statutory Bodies viz., Finance Committee, Executive Committee etc., should ensure this conditionality."

The Central University of Jharkhand has implemented the revised salary to its teaching and non-teaching employees according to 7<sup>th</sup> Central Pay Commission from the month of February 2018 onwards.

The difference on account of payment of salary to teaching and non teaching employees on the basis of 7<sup>th</sup> Central Pay Commission works out to be Rs.20.00 lacs (approx.) per month.

The Central University of Jharkhand has requested for an amount of Rs.5.00 Crores from University Grants Commission due to revision of salary along with payment of arrear for the period from 01.01.2016 to 31.01.2018, whereas University Grants Commission vide its letter No.F.32-1/2017(CU) dated 13.03.2018 has approved an amount of Rs.4,00,68,000 (Rs. Four Crores sixty eight thousand) only. An amount of Rs.99,32,000.00 (Rs. Ninety Nine lacs thirty two thousand) only is required as shortfall under salary head for payment of arrears. Financial implication is placed at Annexure-I

Internal Receipts (Interest earned on the grant received and Academic Receipts/ Fees/ Other receipts etc.) of the University is Rs.14.24 Crores (approx.) for the financial years 2016-17 and 2017-18.

After detailed discussion and deliberations in the meeting with the Hon'ble members of the Finance Committee, following points were highlighted as the obstacles in meeting 30% additional financial burden on account of salary of Non-Teaching employees of the University for implementation of 7<sup>th</sup> Central Pay Commission recommendations.

- (i) The University has come into existence in the year 2009 and is operating all its academic and administrative activities only in the temporary campus available with inadequate resources and staff to cater the need for the University.
- (ii) Due to space constraints, the University has limited intake of the students in various disciplines which results into lower collection of internal receipts for the University.
- (iii) Under such circumstances, the University is not in a position to meet out additional financial implication on account of additional liability of 30% for implementation of 7<sup>th</sup> Central Pay Commission recommendations i.r.o. non-teaching staff.

The Finance Committee considered and recommended the proposal for payment of arrears on account of implementation of recommendations of 7<sup>th</sup> Central Pay Commission w.e.f. 01.01.2016 to 31.01.2018 to Teaching and Non-Teaching employees of the University.

The Finance Committee also recommended to place the proposal and request UGC for an additional amount of Rs.99,32,000.00 (Rs. Ninety Nine lacs thirty two thousand) to meet the shortfall under salary head for payment of arrears to Non-Teaching employees.

The meeting concluded with a vote of thanks to the chair.
