## **Resolution**

# FC: 2022/23/06 To consider and approve to engage additional outsourced personnel

A letter No. F.74-6/2012(CU) dated 03/01/2022 received from UGC, in response of our letter requesting for increase in Annual Allocation under Recurring Head & Sanction to engage additional outsourced personnel at Central University of Jharkhand, Ranchi, in which UGC has requested to place the matter of sanctioning to engage additional outsourced personnel at Central University of Jharkhand before the Finance Committee Meeting. Thereafter, University may approach to UGC with detailed proposal and financial implication for additional outsourced staff.

Presently the University has sanction for 100 outsourced manpower, and the University needs sanction of additional manpower of 235 personnel urgently in various categories viz. Security Guards, Housekeeping /Safai Karamchari, Sweeper/ Bathroom Cleaner, Gardener/ Mali, Electrician/DG Operator, Plumber, Driver, Data Entry Operator etc. for seamless day to day functioning of the offices/ departments at both the campuses, as the University is presently operating from both the campuses (Area – 500 acre at Cheri-Manatu (Permanent Campus) and 45 acre at Brambe Campus) with Administrative Offices & more than ten Academic Departments at Cheri-Manatu Campus and remaining Departments, residential quarters & old hostels at Brambe Campus.

The Finance Committee discussed the matter and resolved to increase sanction of additional manpower of 110 security Guards from 70 & appropriate number of skilled & unskilled

of minor original works / repair works for Campus Development etc; the minutes of the Building Committee is considered and approved subject to:

- 1. Each project is fully funded and the entire funds have been allocated by the University / released by UGC / are available with the CUJ, for each individual project.
- 2. No additional funds for these projects will be sought from MoE/UGC for the projects. Further no part of the internal receipts, UGC / MoE Grant including interest accrued on each such grant will be utilized.
- 3. Abstract of Cost and Rate Conformity Certificate as also other related codal formalities for each Building Project are strictly as per relevant UGC guidelines. Further, award of "Civil Works" is strictly as per the relevant provisions of GFRs, 2017 and related CVC guidelines.
- 4. Ratification of "award of Civil Works" and execution thereof is subject to strict compliance of GFRs, 2017 and related CVC guidelines.
- 5. It is advised that University should adhere to the DPR approved. If any deviation/modification/revision is needed, the approval of the competent authority may be obtained.
- 6. It was further instructed that a summary report of each Building Committee Minutes specially a) Sanction of fund required for a new project or b) Sanction of additional fund for an existing project or c) Revision of estimated cost of an existing project or d) Involvement of any financial factor may be placed in the FC meeting in addition to total minutes of each Building Committee meeting.

UGC vide its letter dated 16<sup>th</sup> March, 2022 has conveyed its no objection on the proposal for creation for seven (07) new departments in the University subject to the condition that the Ministry of Education may provide approval of the teaching posts. Admission notification (2022-23) has already been released for the proposed departments and it is expected that classes shall start from the month of July, 2022. The teachers are required to engage the classes and hence sanction of teaching positions is required at the earliest. Creation of non-teaching posts are also required for smooth running of these new departments.
