## ADDENDUM TO ADVT. NO. CUJ/Advt./2016-17/03 dated 24.05.2017

## IMPORTANT NOTICE TO THE APPLICANTS APPLIED FOR THE POST OF FINANCE OFFICER

The University vide its Advt. No. CUJ/Advt./2016-17/03 dated 24.05.2017 advertised the Non-Teaching Positions for the post of Finance Officer.

- 1. The Screening Committee checked and verified the records of each applicant and determined their eligibility strictly in accordance with the qualification prescribed by the University vide Advt. No. CUJ/Advt./2016-17/03 dated 24.05.2017.
- 2. Applicants not meeting the eligibility requirements as per the advertisement were declared Not Eligible and reasons for declaring an applicant as ineligible are clearly indicated against their names. Further, the Screening Committee could not assess the candidature of applicants whose hard copy of the application not received.
- 3. The list of all applicants who have applied for the post of Finance Officer, giving general information and decision of the Committee with regard to their eligibility and non-eligibility along with the reasons thereof is placed in the **TABLE-A**.
- 4. It may be noted that: (a) Decision with regard to Short-listing of applicants has been made on the basis of their claim/information/certificates furnished/attached in their application forms. (b) Further, while deciding as to whether an applicant is eligible or not, the Committee has considered the educational qualification, experience, percentage of marks, category etc. furnished by the candidates. (c) Applicants shall have to substantiate their claim through documentary proof at the time of the Interview. (d) Applicants must ensure that their details are correct and that they meet the minimum eligibility requirements, failing which they shall not be allowed to appear for Interview before the Selection Committee. (e) The eligibility of the applicants has been determined as on the last date of receipt of applications.
- 5. Applicants are advised to go through their details carefully given in Table A and in case of any discrepancy, the applicants are advised to bring the same to the notice of the University for necessary correction(s) clearly mentioning the name of post, name of the department and page no. at which their name figures in the list by writing an email to recruitmentcell@cuj.ac.in latest by 18<sup>th</sup> August, 2017 with supporting documents.
